#### RESIDENTIAL CARE



#### LARGE **EVENTS**



Avoid travelling outside your area, other than where necessary such as for work or education. Further exemptions apply. Reduce the number of journeys where possible Plan ahead and avoid busy times and routes on public transport. Avoid car sharing with those outside of your household or support bubble.

Classes and organised adult sport can take place outdoors, but people should avoid higher-risk contact activity. Group exercise activities and sports indoors should not take place, unless with your household or bubble. Organised activities for elite athletes, under-18s and disabled people can continue.

COVID-secure arrangements such as substantial screens, visiting pods, and window visits. Outdoor/airtight visits only (rollout of rapid testing will enable indoor visits including contact).

Events should not take place. Drive-in events permitted.

With the nights drawing in earlier, please can I remind those of you that cycle or children cycle to ensure that you/they have correct reflective clothing and lights. We have had reports of youngsters riding in and out of traffic dangerously doing wheelies in the local villages and towns.

#### E-Scooters – Know the law

Although e-scooters can be great fun, it's against the law to ride one on a public road, cycle lane or pavement.

#### What you need to know:

E-scooters are classed as Personal Light Electric Vehicles (PLEVs), which means they are treated as



motor vehicles and subject to the same legal requirements, such as driving licence, insurance, number plates, lighting, road tax, crash helmets etc. **Without these, e-scooters cannot be used legally on the road**.

The Government is currently trialling the use of approved rental e-scooters as environmentally friendly modes of transport in some specific locations in the UK.

For the rest of the country, under current law, e-scooters can only be used on private land.

# What should I do now?

It's our priority to keep you and other road users safe.

We are obliged to take action against anyone who is caught repeatedly using an e-scooter illegally or in a way that causes a nuisance to others. In these circumstances we have the

power to seize the e-scooter under Section 59 of the Police Reform Act/165 of the Road Traffic Act – and we'd really prefer not to.

Thank you for cooperating with us today and agreeing not to use your e-scooter on a road, cycle lane or pavement.

From now on, please make sure you only use your e-scooter on private land.

# **Security Advice**

With the Christmas period nearly over please can I remind everyone about not leaving wrapping and boxes outside your home as this can advertise rich pickings inside. Please wait until the day of your next refuse collection or take it to the tip.



### Leaving your home checklist

Whenever you go out, it's important to leave your home secure. Getting into an 'exit routine' can help ensure that you don't forget obvious, but important things, like not leaving your valuables near windows, or no lights on if it will be dark before you get home. Here's our quick reminder on what to do just before you go out.

#### Become a creature of habit

Try to get into the habit of following your own course of action when you lock up your home. This will ensure that you don't forget anything.

Here's what we recommend you do before you go out:

- close and lock all your doors and windows, even if you're only going out for a few minutes
- double-lock any door
- make sure that any valuables are out of sight
- keep handbags away from the letterbox or cat flap and hide all keys including car keys, as a thief could hook keys or valuables through even a small opening
- never leave car documents or ID in obvious places such as kitchens or hallways
- in the evening, shut the curtains and leave lights on
- if you're out all day, then it's advisable to use a timer device to automatically turn lights and a radio on at night
- set your burglar alarm
- make sure the side gate is locked
- lock your shed or garage

 lock your bike inside a secure shed or garage, to a robust fitting bolted to the ground or wall, like a ground anchor

# **ASHFORD RURAL BURGLARY**

These items were stolen the other night from the Rolvenden area, please keep your eye out for them. Report anything you know via 101 or online.





#Ashford has recently seen an increase in number plate thefts. Criminals will attach the stolen plate to their own #vehicle so that they can commit crimes. Report stolen registration plates to #KentPolice as soon as possible and please consider using anti-theft screws. LL



There has also been an increase in thefts of number plates across the Ashford district. This is spread across rural and urban areas.

This is happening all hours of the day and from driveways, roadside and car parks. Unfortunately, it is so easy for criminals to remove plates which they will then clone and use to commit further crimes: burglaries, robberies, bilking etc.

# What's available / Crime Prevention:

- Anti-theft Number Plate Bolts These are virtually non-removable without the specialist locking tool. It is not going to guarantee it is going to stop plates getting stolen but will certainly make it harder / longer for criminals to do so. These can be purchased in places such as Halfords, Euro car parts or main dealerships should also be able to provide.
- Try to secure vehicles in a garage if available. If not, park in well-lit areas ideally overlooked by properties.
- CCTV / Dashcams

#### Theft of cosmetics from Ashford and Tenterden

CCTV images have been released by officers of a man they believe may have important information regarding hundreds of pounds-worth of cosmetics stolen in Ashford and Tenterden.

Officers are investigating a theft of more than £500 worth of Vichy Dermablend products from a business in Tenterden High Street on 3 August 2020, at around 11.15am.

A second theft was reported on 20 October 2020 at 10am from a business in Mill Court, Ashford, where around £300 worth of Rimmel make-up was stolen.

# Rings, earrings and an ankle bracelet stolen in Tenterden



Information is being sought after jewellery was stolen during a suspected burglary at a Tenterden property.

It was reported that on Friday 2 October 2020 a resident of Rothley Close left their home and when they returned a window was open. They later noticed that jewellery was missing. Items reportedly stolen include a gold wedding ring, a gold signet ring, a small gold ring, a pair of gold cross earrings, a pair of silver earrings and a gold ankle bracelet.

# **DPD Phishing Email.**

I have had a report this week of a person receiving an unsolicited email from fraudsters claiming to be the delivery company DPD. It stated that they had tried to make a delivery but that the person had not been at home. They were requested to click a link. This was a scam and I would ask you to be vigilant at this time with so many more of you shopping online.

This particular Phishing email was sent from a Hotmail address and addressed the intended victim by the email name, as opposed to Mr or Mrs etc. Both of these raised alarm bells with the intended victim.

Always check the senders email address details and if unsure, apply ABC and ring a trusted number to confirm that it is genuine. Never click links or divulge personal or Banking data. If you receive phishing emails like this please forwarded them to report@phishing.gov.uk for further investigation

# Scammers impersonating Age UK.

From our colleagues at Kent County Council Public Protection, they have received reports of a resident in Ashford being targeted by Scammer(s) impersonating Age UK. They are calling intended victims and asking questions including the name of their Doctors Surgery and medication they may be taking. It is a scam, as Age UK would not call and ask for personal information.

End the telephone call and make sure the line has cleared.



# Fake Penalty Charge notices.

# **SCAM WARNING**

# Be on the lookout for fake penalty charge emails.

The email, which purports to be from HM Courts & Tribunals Service, states that the recipient has been issued a penalty charge for "the use of a vehicle on a road in the charging area which a charging scheme applies without payment of the appropriate charge". The links provided in the emails lead to genuine-looking phishing websites that are designed to steal personal and financial information.

- Your bank, or any other official organisation, won't ask you
  to share personal information over email or text. If you need
  to check that it's a genuine message, call them directly.
